
Machine Learning based recommendations in Access Reviews

Inactive user recommendation considers activity based on last sign in date



Entitlement Management with verifiable credentials

- Reduces need for self-attestation by business partners. Users requesting access will be able to obtain identity attributes from a wide set of issuers.
- Simplifies approval processes, as approvers do not need to vet requestor's authenticity of claims.
- Simplifies compliance posture with reduced need for manual validation.
- Example of better together Microsoft Entra combinations; others include ID Governance + Workload IDs, ID Governance + External IDs



Employee onboarding

- → After interview, an employer can make a hire, but in this era of prolific homeworking, the employer needs to ensure that the worker who turns up on day 1 is the person they hired.
- → The employee can acquire a credential from a trusted source, e.g. UK Government.
- → This can then be presented on the employer site to kick off the Entra ID account creation process and complete onboarding.



Events / Tickets

- → The event registration site issues a virtual ticket
- → Customer stores the ticket on their mobile app (authenticator or preferably a branded mobile app)



→ Ticket checked at the door using a tablet or laptop




Age verification

- → Many UK websites need to take effective steps to protect children online, as part of the Online Safety Act https://www.ofcom.org.uk/news-centre/2024/how-the-online-safety-act-will-help-to-protect-children
- → Verified ID can help by providing a trusted credential with a date of birth attribute, e.g. from the UK government.
- → Any website can use the Verified ID framework to verify this credential.



Anonymous website entry


- → Issuer: Employer or Membership body
- → Credential presented on (for example) research site to give the user the ability to browse research papers, but identity does not need to be tracked..
- → .. or the credential is required as a prerequisite for sign-up. Non members/employees are not permitted to create an account.



Helpdesk/Ticketing scenario

- → A typical issue for helpdesk is to determine if the person on the phone calling to get help is really the person who they say they are.
- → Users (e.g. employees or clients) can carry a credential in their digital wallet
- → While on the call, users can verify their credential against a verifier application, and helpdesk agents will be notified of this action
- \rightarrow They can then proceed with the call
